**1. Permits, Change, Transfer, Renewal, Sale**

No permitting action at this time.

**2. Signs and Markers**

The identification signs at the gates meet the minimum requirements of the R645 Coal Rules. The signs are hanging on the chain link gates at the Fourth East Portals.

**3. Topsoil**

There is no change since the last inspection. The topsoil piles are stable with no signs of wind or water erosion. Vegetation should develop shortly on the reconstructed vegetation piles along the main road to the property.

**4.a Hydrologic Balance: Diversions**

Diversions and culverts are maintained. No water was flowing within the diversions during the inspection.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

All sediment ponds were dry except the pond collecting underground water. No hazardous conditions were notice during the inspection. Most of the sediment ponds are incise. The embankments were stable. The permittee was repairing the inlet to the sediment pond by the road going to the 4th East portals. The high winds moved the half culvert. See Picture.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The refuse pile was inspected with no hazardous conditions noticed during the inspection. There is only a small amount of material at the site. The slopes of the pile were stable.

**8. Noncoal Waste**

The mine site was clear of non-coal waste materials.

**10. Slides and Other Damage**

No slides or other damage was notice during the inspection.
