**1. Permits, Change, Transfer, Renewal, Sale**

There is one amendment under review by the Division, task # 4865 soil data from the mine. The due date for completing the review is May 8, 2015

**9. Protection of Fish, Wildlife and Related Environmental Issues**

The mine is currently inactive. However annual owl surveys were conducted previously during active mining operations. Since panel was only first mined there was no planned subsidence or an opportunity to determine if mining related subsidence would have an impact on the natural and artificial burrows. During this site visit one third of the study area was inventoried for presence of burrowing owls. The site will be visited several times during the next several weeks to complete the four surveys as required by the survey protocol. Those surveys will consist of visual observations from reproduced owl calls and scanning with binoculars and a spotting scope.
