2. Signs and Markers

The identification signs at the gates meet the minimum requirements of the R645 Coal Rules.

3. Topsoil

The topsoil piles were inspected. There were no signs of wind or water erosion. The topsoil piles by the highway to the mine were recently redesigned. This was done in order to establish vegetation on the topsoil piles. Some vegetation has started to grow on the newly configured pile. It appears to be grass species.

4.a Hydrologic Balance: Diversions

I inspected the diversions and culverts. A culvert inlet had some sediment in front from the recent rainstorm in the past couple of weeks. Water would still go through the inlet of the culvert. The permittee said that the inlet will be cleaned out.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the sediment ponds and no hazardous conditions were noticed. The embankments were stable with no signs of erosion. The sediment ponds were basically dry.

8. Noncoal Waste

The site was clear of non-coal waste materials.
