2. Signs and Markers

The identification signs at the gates meet the minimum requirements of the R645 Coal Rules.

3. Topsoil

There is some vegetation growing on the topsoil piles that were re-contoured this spring. There are no signs of wind or water erosion. The topsoil piles appear to be stable.

4.a Hydrologic Balance: Diversions

The diversions and culverts were inspected. They were open and would function as design. No water was flowing within these structures during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds contained little to no water. They appeared to be stable with no signs of embankment failure. There were no signs of erosion to the inlets or outlets of the sediment ponds. It is unlikely these sediment ponds will discharge this year.

5. Explosives

No explosives are on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile is small. There were no hazardous conditions noticed during the inspection. The embankments were stable.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage were noticed during the inspection.

16.a Roads: Construction, Maintenance, Surfacing

Roads were maintained with road drainages function as design.

18. Support Facilities, Utility Installations

The facilities are idle with the office being used.
