

1. Permits, Change, Transfer, Renewal, Sale

There is no permitting action currently pending with the Division. However, the DOGM permit is up for renewal in January 2016.

2. Signs and Markers

The identification signs at the gates meet the minimum requirements of the R645 Coal Rules. They are located at the main gates to the property.

3. Topsoil

The topsoil piles were inspected, and, there were no signs or wind and water erosion. It appears that mainly weeds are growing on the two areas recently recontoured and reseeded. See Pictures

4.a Hydrologic Balance: Diversions

I check diversions and they were functioning as design. The culverts were also open. No water was flowing within these structures during the inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sediment ponds contain little to no water. I did not see any hazardous conditions to these sediment ponds. The embankments appear to be stable. These sediment ponds are unlikely to discharge in the near future.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile during the inspection. It was stable with no hazardous conditions notice. The refuse pile is small.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or other damages were notice during the inspection.
