PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits seven clean copies of Volume 9: text section, Appendix A, Appendix B - Cottonwood UPDES permit and Maps HM-1 and HM-4, of the Cottonwood Mine C/015/019, Deer Creek Mine C/015/018 and Des-Bee-Dove mines MRP's. This amendment was conditionally approved for incorporation into the MRP on March 8, 2002. Revisions to Volume 9 are in response to the temporary cessation of the Cottonwood Mine which resulted in the re-location of Utah Pollution Discharge Elimination System (UPDES UT-0022896) outfall 001 from Grimes Wash to Cottonwood Canyon: Trail Mountain Access (TMA). In addition, Appendix A - Hydrologic Monitoring Program has been revised to clarify T-18 (Oliphant Mine Discharge) as a groundwater source.


