4.b Hydrologic Balance: Sediment Ponds and Impoundments

The pond has not yet been surveyed for the third quarter. There was only 0.05 acre-feet of sediment capacity remaining at the end of the second quarter. The third quarter survey is expected to be done next week, and a copy will be sent to the Division. Recent storms have added sediment to the pond, and there may be no sediment storage capacity remaining.

4.e Hydrologic Balance: Effluent Limitations

Discharge from the sedimentation pond is the only water sampled at this site. There was no water-quality report or DMR for the third quarter at the time of the inspection, but there does not appear to have been any discharge from the pond. A copy of the UPDES DMR will be sent to the Division.

8. Noncoal Waste

Non-coal waste continues to appear at the surface of the reclaimed areas. Small items are removed as they are found; larger items, which are usually partially buried, are removed when feasible.

9. Protection of Fish, Wildlife and Related Environmental Issues

There is evidence of deer on this site, but wildlife is not abundant - due mainly to the dryness of this canyon - and there are no wildlife related issues.

13. Revegetation

Forbs and grasses from the applied seed are sprouting and growing, but because of recent dry conditions the vegetation is not abundant.

21. Bonding and Insurance

The insurance certificate is held by the Utah Division of Natural Resources. The policy expires 4/1/2004
