13. Revegetation

Juniper (200 in containers), mountain mahogany (1,500 in containers), and serviceberry (1,350 bare-root) were planted last week, and ~6 inches of snow (0.4 inches of water in the rain gauge) fell the following day. The mountain mahogany and juniper appear to be doing OK; all but a few of the serviceberry appear to still be dormant. Pinion and additional juniper will be planted this fall if conditions are suitable.
