Subject: Confidential and Protective Information Amendment, PacifiCorp, Cottonwood Mine, C/015/019, Des-Bee-Dove Mine C/015/017, Deer Creek Mine, C015/018, Trail Mountain Mine C/015/009, Emery County, Utah

PacifiCorp received a letter dated December 8, 2004, stating that confidential, protected and private information as identified in the letter be removed from the currently approved MRP's. The letter states that the following information according to the Government Records Access Management Act (GPAMA), the location of historic, cultural or biological resources must be "protected". The locations of raptors and threaten and endangered species must be "protected". To conform to the request PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits a new volume entitled "Confidential and Private Information" to relocate confidential and protective information from the MRP's to the confidential binder.

The Confidential and Private Information Volume includes "index tabs" for each of PacifiCorp's mining operations in Emery County along with a "East Mountain General Tab" applicable to Cottonwood Mine, C/015/019, Des-Bee-Dove Mine C/015/017, Deer Creek Mine, C015/018 operations. Attached is the required C1 and C2 forms along with one (1) copy of the Confidential and Private Information volume. Included within the volume is high quality copies of the archeological reports completed and referenced in the MRP's.

PacifiCorp will follow up this submittal with individual amendments to remove/relocate confidential and private information from each operation.




