

PacificCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits an application for a permit renewal of the Des-Bee-Dove Mine solely for the purposes of conducting reclamation activities. Final reclamation has been conducted in most areas of the mine and will continue this year. All reclamation is planned to be completed in 2005. The permit area encompasses approximately 154 acres as located on the area map below.



A surety bond is filed with the Division of Oil, Gas and Mining in the amount of \$1,837,712.00, and is payable to the State of Utah, Division of Oil, Gas and Mining (DOG M), and the Office of Surface Mining Reclamation and Enforcement (OSM).

Said comments must be submitted thirty (30) days from the date of the last publication of this notice. This notice is being published to comply with the Surface Mining Control and Reclamation Act of 1977 and State and Federal regulations promulgated pursuant to said Act.
