2. Signs and Markers

Pending the Division's approval of the BLM right-of-way relinquishment amendment, the boundary markers at the sedimentation pond will be relocated and the new locations GPSed.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sedimentation pond is frozen.

4.d Hydrologic Balance: Water Monitoring

There was no discharge in December, and the water and ice in the sedimentation pond are well below the spillway elevation. The UPDES discharge from the pond is the only water-monitoring point.

4.e Hydrologic Balance: Effluent Limitations

There was no UPDES discharge in December; the January DMR has not been filed yet.
