Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

There is some new vegetation growth, mainly grasses and a few mountain mahogany. The stakes that were seen in March are for a TXO gas well. TXO has been in discussions with the USFS and Energy West, re: the location of this pad and reopening of the lower part of the reclaimed road. Also, the OHV users have obtained easements from all landowners except PacifiCorp for the proposed Arapien Trail, which will include the Des Bee Dove section of the cattle trail: PacifiCorp will grant the easement across their property when the post-mining land use change is approved. PacifiCorp will submit both the OHV and TXO post-mining land use changes as one amendment.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

Dennis indicated decanting of the pond would begin soon, in anticipation of reclamation this coming summer or fall.
