The pond has dried somewhat since the last inspection, otherwise no change.

4.d Hydrologic Balance: Water Monitoring

The DMR for April shows no discharge. The pond discharge is the only water-monitoring point.

4.e Hydrologic Balance: Effluent Limitations

The DMR for April shows no discharge.

13. Revegetation

Growth is not spectacular but seems to be progressing in the Phase 1 and 2 areas. USFS recommended placing the TXO pads on the pump house reclaimed area, which has had good growth since seeding. It's disappointing to lose an area that has had such good revegetation growth, but redistributing this is preferable to disturbing new area.
