This was part of series of inspections done during sedimentation pond reclamation. On 12/14/2005, the contractor was mixing wet soils from the bottom of the sedimentation pond with drier soils from the soil stockpile, then pushing the mixed soils, in lifts, against the cutslope. On 12/20/2005, the activity was still the same. Between the two dates, the Permittee added stakes and flagging to more clearly mark the permit area boundary.

2. Signs and Markers

Dennis Oakley added stakes and flagging to more clearly mark the permit area boundary so the contractor will not operate outside of it; the disturbed area and permit area boundaries are very close in some locations around the pond, and coincide along the road. The sign at the mine site continues to be vandalized by firearms, and will probably need to be replaced some time next year.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The sedimentation pond is being reclaimed. At the time of the inspection, it still had the capacity to retain water and sediment.

9. Protection of Fish, Wildlife and Related Environmental Issues

Even with the ongoing earthwork at the sedimentation pond, deer are still using the area as shown by fresh tracks in recent snow.
