**Re: Rescission Request for "Response to Deficiencies from Division on the Legal and Financial Information, for the Cottonwood/Wilberg Mine, C/015/019, Deer Creek Mine, C/015/018, and Des Bee Dove Mine C/015/017, and Trail Mountain Mine C/015/009, Emery County, Utah, Task #2477".**

PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby requests that the above deficiency response document dated June 16, 2006 be rescinded from Division records.

The rescission of this document was requested by the Division because more information was submitted by the permittee than what was requested. The Technical Analysis Deficiencies required the permittee to submit only the updated lease information related to lease relinquishment for Appendix C of the Legal and Financial Volume. However, the permittee submitted updated information for the entire Legal and Financial Volume.

Although this updated information is needed for the entire Legal and Financial Volume, the Division felt that the submittal would cause confusion to the amendment pertaining to Task ID #2477. Therefore, the permittee will rescind the above stated document and resubmit two separate documents: 1) deficiency response document for Task ID #2477 titled "**Response to Deficiencies Pertaining to Phases I, II, and III Lease Relinquishment, PacifiCorp, Deer Creek Mine, C/015/018, Emery County, Utah, Task #2477**"; and 2) updated information for the Legal and Financial Volume titled "**Amendment to the Legal and Financial Volume to Include Updated Information, PacifiCorp, Cottonwood/Wilberg Mine, C/015/019, Deer Creek Mine, C/015/018, and Des Bee Dove Mine C/015/017, and Trail Mountain Mine C/015/009, Emery County, Utah.**"


