The channel running through the reclaimed sediment pond area contained stagnant water.

12. Backfilling And Grading

The reclaimed sediment pond area did not reveal any slumps of ground.

13. Revegetation

Vegetation continues to develop in the reclaimed sediment pond area; summer rains are helping to keep new growth alive.

21. Bonding and Insurance

The Permittee has renewed the general liability insurance coverage for the Energy West properties until August 28, 2007.

22. Other

The Permittee has submitted a Phase III bond release application for the area associated with the XTO coal bed methane well located near the end of the Mine site turn-around area. The Division has approved this Notice of Phased Bond Release application for this well for publication in local newspapers.
