PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company as mine operator, herewith submit the Annual Reports for 2006.

This year Energy West is submitting the Annual Report in two ways; One (1) paper copy, and two (2) CD electronic copies. The electronic copies are provided as a trial basis. It is our hope that this is an acceptable format for the Division. To use and review the documents, insert the CD provided into a computer. The drive directory should automatically appear on your screen. If not, go to "My Computer" and click on the appropriate CD drive. Once the directory appears correctly on your screen, you will notice four files; 2006 Hydrologic Report.pdf, 2006 Subsidence Report.pdf, Annual Report-2006.pdf, and Confidential Maps.pdf. Choose and click on a file to review.

There are two things to note when reviewing these files. First, the Hydrologic and Subsidence reports are supplied with links embedded in the text. You will find links to appendices, figures, and charts in the Table of Contents and within the text. If you find it necessary to print this document, click on "File" from the pull-down menu and select "Print".

Secondly, there are two (2) confidential maps included with the General Information. The CD Confidential Maps.pdf file is password protected with the password being "pacificorp". This password is used to keep the public from viewing these confidential maps. The paper copy includes the maps contained within a manila envelope stamped "CONFIDENTIAL".

Please find enclosed one (1) copy each of the General Section (all forms and activities of the above mines related to coal mining and reclamation monitoring during the 2006 year), Annual Hydrologic and Subsidence Reports for 2006 as a paper and two (2) copies of the aforementioned on CD.
