1. Permits, Change, Transfer, Renewal, Sale

The permit will expire on August 20, 2010. The Division has granted a Phase III bond release for a small area being use for gas drilling. It was a good idea for the Division to grant the permittee release of additional area for the gas drilling. The drilling company has disturbed additional area beyond what was projected.
