Identification signs was located on the trail to the mine.

3. Topsoil

All topsoil was used in Reclamation.

The disturb area is pocked for sediment control.

7. Coal Mine Waste, Refuse Piles, Impoundments

There are no coal mine waste piles at this site.

The reclaim area was clear of non-coal waste material.

Wildlife has been grazing on the site.

10. Slides and Other Damage

No slides were noticed during the inspection.

12. Backfilling And Grading

The site was backfilled and graded.

13. Revegetation

It is to early in the season for new vegetation to come up from the ground.

15. Cessation of Operations

The mine is completely reclaimed.

22. Other

The permittee will fixing a couple of erosion rills through the trail area.
