1. Permits, Change, Transfer, Renewal, Sale

The DOGM permit will expire on Aug.30, 2010.

2. Signs and Markers

The identification sign is located on the trail to the property. Information contained the information required in the R645 Coal Rules.

3. Topsoil

All topsoil was used in reclamation. There were no signs of erosion on the reclaimed lands.

4.a Hydrologic Balance: Diversions

Several diversions were spot-checked with no signs of water erosion.

4.c Hydrologic Balance: Other Sediment Control Measures

The entire site is pocked to prevent sediment from leaving the reclaim area.

6. Disposal of Excess Spoil, Fills, Benches

Portals have been backfilled.

8. Noncoal Waste

The mine site was clear of non-coal waste materials.

10. Slides and Other Damage

No slides or damage was noticed during the inspection.

12. Backfilling And Grading

The mine site is completely backfilled and graded.

13. Revegetation

The mine site has been seeded and vegetation is growing on the site.

21. Bonding and Insurance

The insurance will expire on Aug. 28, 2010. The company affording coverage is ASSOC. Electric & Gas Ins Serv LTD. The bond amount is \$1,169,718. The reclamation agreement was inspected and was signed by both parties.
