The Office of Surface Mining and the Division of Oil, Gas and Mining (Division) have completed a review of the Mining and Reclamation Plan (MRP) and amendments submitted by Utah Power & Light Company for the Deer Creek Mine. The regulatory authorities determined the plan to be apparently complete on February 2, 1984. In compliance with Section UMC 786.11(b) and (c) of the Utah Coal Mining Reclamation Act (UMC, Section 40-10-1 et seq.), notice is hereby given to all appropriate agencies having jurisdiction over or an interest in the area of the operations that a complete plan is available for public review.

The Deer Creek Mine is located in Deer Creek Canyon, approximately 12 road miles northwest of Huntington, Utah. The following are the legal descriptions of the permit area:

No decision will be taken by the Director for a minimum period of 30 days after submission of this Notice of Availability to the appropriate agencies.
