The Utah Division of Oil, Gas and Mining (Division) is granting approval and issuing a five-year mining permit to Utah Power & Light Company. The Division has determined that the permit application is technically complete and demonstrates compliance with all the "Regulations Pertaining to Surface Effects of Underground Coal Mining Activities, Final Rules of the Utah Board and Division of Oil, Gas and Mining," promulgated under the Utah Coal Mining Reclamation Act (Utah Code Annotated 1953, Section 40-10-1 et seq).

Notice is hereby given to all appropriate agencies and individuals having jurisdiction over, or an interest in the area of the proposed operations, pursuant to UMC 786.23(d)(e)(f), that a permit has been issued to said permittee.

This permit authorizes the permittee, Utah Power & Light Company, to conduct mining and reclamation operations on the described lands within the permit area at the Deer Creek Mine situated in the state of Utah, County of Emery, subject to the terms of the lease(s), the approved mining and reclamation plan, this permit and all applicable laws and regulations.
