1. PERMIT, CHANGE, TRANSFER, RENEWAL, SALE

Only the Rilda Canyon Surface Facilities area was inspected during this partial inspection. Approximately 44 cubic yards of fill material had been brought on site from the contractors borrow area near the mouth of Huntington Canyon. The approval for the Surface Facilities (letter dated 7/31/95) was conditioned upon the demonstration of the suitability of the fill material prior to being brought on site. Violation N95-35-02-01 was issued.
