2. SIGNS AND MARKERS

Disturbed area markers could not be located at the undisturbed culvert trash rack in Deer Creek Canyon and in the Powder Magazine area.

7. COAL MINE WASTE/REFUSE PILES/IMPOUNDMENTS

Slopes on the refuse pile had been reduced to the committed 2:1 slopes, except on the final east slope which is currently being graded. The access to the north cell of the pile had been changed to enter at the south west corner. The surface had been compact with a greater grade to facilitate drainage.

18. SUPPORT FACILITIES/UTILITY INSTALLATIONS

Access into the permit area in Rilda Canyon was block with large boulders. This should help protect the topsoil resource.
