Rilda Canyon Surface Facilities

The site was in good condition and diversions handled recent rains as designed. Most work is completed on site except for a few items as follow:

- silt fence at pad gate,
- berm on pad near pump house needs to be "beefed up"
- detention basin at culvert outlet near service gate should be eliminated,
- some seeding
- and removal of silt fence at culvert outlets.

Deer Creek Facilities

The site was in good condition and drainage systems functioning as designed with recent rains. The diversion on south side of conveyor, although functioning, was being used as a storage area for various pieces of mining equipment. A belt uptake was also in front of the outlet of the bermed area. All equipment should be cleared out of the drainage.

The sediment clean out box had recently been cleaned and pond discharge water looked clear.
