PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby acknowledges that all ownership and control information is current and up to date as of February, 2003.

During the last deficiency response of the Division's January, 2003 technical analysis, Energy West removed Volume 12, R645-301-100: General Information from the Mill Fork Tract permit application. This information, however, was simotaneously updated in the Volume 1, R645-301-100: General Information text section and in Volume 4, maps 1-1 and 1-2 (Coal Ownership and Surface Ownership, respectively). The C1/C2 forms in the February 12, 2003 submittal lists this action.

This letter is intended to satisfy the Utah Coal regulation R645-301-112.900 which requires the permittee to update, correct, or indicate that no change has occurred in the information previously submitted under R645-301-112.100 through R645-301-112.800.
