There are two sets of listing for each company. These listing are: (1) current officer and director which only listing the current officer and director, (2) Summary of officer and Directors which listing current officers with election date and departure officers with departure date

The following are some areas that need to be resolved with the company

Scottish Power, PLC

Listing 2 has departure date 06-02 for Allan Leslie Leighton, his name should be removed from listing 1.

If Nick Rose is a current director, his name needs to be included in the listing 1 (unless there is a second page that you did not fax to me) ? Or if he is no longer a director, then there should be a departure date on listing 2

Alan V. Richardson need to be in listing 2 with departure date 01-01 as Director.

AVS listed Charles Murry Stuart as corporate officer 3/1/90, but his name is not listed on both documents. According to Johanna Cramer from CO, Sherice is looking into this issue. We need to know if he should be remain in AVS as corporate officer?
