PacifiCorp, by and through its wholly-owned subsidiary, Energy West Mining Company ("Energy West") as mine operator, hereby submits the clean copies to update the current mining conditions at the Deer Creek Mine. As denoted on Map 3-7, longwall mining in the Hiawatha Coal Seam on North Rilda Ridge will be completed in August 2004. After completion of the 8th Right Panel, the longwall will be moved south to complete mining in four miscellaneous panels in the Blind Canyon Seam prior to moving to the Mill Fork Lease, refer to Map 3-6.
