Report summary and status for pending enforcement actions, permit conditions, Division Orders, and amendments:

Permit Conditions:

- 1) During entry development if sustained quantities of groundwater are encountered which are greater than 5 gpm from a single source in an individual entry, and which continue after operational activities progress beyond the area of groundwater production, PacifiCorp must monitor these flows and notify the Division within 24 hours prior to initiation of monitoring.
- 2) Vehicle access will not be allowed in Rilda Canyon from December 1 to April 15 for construction and/or maintenance of the Rilda Canyon Surface Facilities without prior written approval from the Division. This condition is for normal working circumstances and does not apply in an emergency situation.
- 3) PacifiCorp will submit water quality data for the Deer Creek Mine in an electronic format through the EDI web site.

The permittee is meeting these conditions at this time.

1. Permits, Change, Transfer, Renewal, Sale

The permittee has two permitting actions with the Division according to the CTS as of November 1, 2004: Supplemental Volume 1 and Volume 11: North Rilda. These actions are under review with the Division.

4.a Hydrologic Balance: Diversions

Several diversions were inspected and functioning as designed. The mine received three inches of rain fall in the past few days.

4.c Hydrologic Balance: Other Sediment Control Measures

Silt fences and dugout ponds were inspected at the mine site. The mine site received three inches of rain and these structures did function as designed.

4.d Hydrologic Balance: Water Monitoring

The permittee submitted water monitoring data into the electronic data system for the second quarter.

8. Noncoal Waste

The mine site was clear of non-coal waste material.

16.b Roads: Drainage Controls

The permittee will be replacing the existing culvert that passes under the road to the mine. The same size culvert will replace the existing culvert. No amendment will be required since this action can be considered as maintenance.

18. Support Facilities, Utility Installations

No support facilities have been constructed since the last inspection.
