**1. Permits, Change, Transfer, Renewal, Sale**

**2. Signs and Markers**

Mine ID signs are in place at the main facilities, waste rock site, and rilda facilities. The signs contain the appropriate information.

New signs have been ordered to show address changes for the SLC office.

**4.a Hydrologic Balance: Diversions**

Several diversions have been cleaned and maintained since the previous inspection.

**4.d Hydrologic Balance: Water Monitoring**

Fourth quarter 2006 water monitoring is in the EDI website, but has not been updated. Water monitoring is current.

**7. Coal Mine Waste, Refuse Piles, Impoundments**

The lower level on the south side was being leveled during the inspection. The upper level has approximately 6-8 vertical feet of storage left before reaching the designed capacity. The pile appeared stable with no visible hazards.

**22. Other**

An underground cave occurred last week in the intake portal of the left fork. The cave was inby the first crosscut from the portal and extended approximately 100'. Equipment and materials to secure and clean up the cave had to be brought in through Rilda Canyon. Energy West notified the USFS and the Division.
