Third quarter 2007 water monitoring information is in the EDI website, but has not been uploaded. Water monitoring is current.

18. Support Facilities, Utility Installations

No activity was present at the Rilda Facilities. Approximately a half a foot of snow was on the road way that had not been traveled upon, nor plowed. Since the previous inspection a rock dust silo has been installed (currently not functional) and some metal beams and skirting has been placed on top of the retaining walls to help hold any non coal waste and or material within the disturbed area footprint. The fan is still running providing ventilation to the underground workings. The operator received permission to transport underground support cans to the Rilda area help support a cave area inside the Rilda portal area. It did not appear that the area had been plowed to provide that access as of the time of this inspection. Activity in this remote area has slowed and may be discontinued due to weather conditions.
