2. Signs and Markers

The mine identification signs at the waste rock site and the main mine facility were at the point of public access to the permit area. Both signs contained the required information.

4.a Hydrologic Balance: Diversions

All diversions are snow covered. Snow has been pushed into the diversion on the ROM (run of mine) pad. The snow needs to be pulled out of the diversion.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed during the inspection of the waste rock site.
