2. Signs and Markers

The mine identification signs are located at points of public access into the permit area. The signs contain the required information.

4.a Hydrologic Balance: Diversions

The diversion that runs along the East side of the waste rock access road has been re-graded.

7. Coal Mine Waste, Refuse Piles, Impoundments

The refuse pile appeared stable. No visible hazards were observed.

8. Noncoal Waste

Noncoal waste control showed a marked improvement from the prior inspection. Personnel was observed during the inspection picking up garbage from remote areas.
