2. Signs and Markers

The mine identification signs are located at the points of public access to the permit area. The signs contained the required information.

8. Noncoal Waste

Noncoal waste was present in the main parking area, along the access road to the main facilities and around the noncoal waste disposal facility. The noncoal waste needs to be gathered and placed in the appropriate storage facility.
