2. Signs and Markers

Mine identification signs are at the point of public access to the permit area. The signs have the required information.

8. Noncoal Waste

Numerous items of noncoal waste items were observed along the main access road to the parking lot, in the main parking lot and around the noncoal waste storage facilities. The amount of noncoal waste items observed was greater than observed on the prior inspection. Dennis Oakley spoke to mine personnel during the inspection to make arrangements to gather the items. Failure to control noncoal waste in the future will lead to enforcement action.
