

2. Signs and Markers

The mine identification signs are located at points of public access into the various portions of the permit area. The signs are identical and contain the required information.

8. Noncoal Waste

Items of noncoal waste were observed along the access road to the main facilities and in the main parking lot. Noncoal items were also observed below the hilfflicker pad and in the diversion at the Rilda facilities. The operator made note of these items and initiated cleanup.

10. Slides and Other Damage

A rock slide was reported to the Division by phone on 10/11/2010 and written notice was received by an e-mail on 10/12/2010. The e-mail had a memo to the file attached. The slide happened on 10/11/2010 at 6:15 am. Two large boulders came down off the hillside or terrace area. The boulders came to rest under the ROM (run of mine) belt. The boulders damaged some concrete jersey barriers and dented some belt equipment. No major damage was incurred. The area was observed during the inspection. The area has been cleaned up.
