Bond Rider Accepted Coal Lease Bond Period of Liability Terminated

On October 11, 2006, a coal lease bond for Federal coal lease UTU-84285, with PacifiCorp, as principal and Travelers Casualty and Surety Company of America, as surety, was accepted by this office. On January 3, 2012, a rider was filed to include Federal coal lease UTU-84285 under the coverage of the East Mountain Logical Mining Unit (LMU) \$2,100,000 bond (No. 103771496) and a request was made to terminate the period of liability of the following listed bond covering this Federal coal lease:

The period of liability of this bond and the rider to the LMU bond could not be accepted until UTU-84285 was formally added to the East Mountain LMU. That action has taken place by decision dated June 5, 2013. Since the Bureau of Land Management (BLM) Price Field Office has determined that the LMU bond adequately covers the bond liabilities on this lease, the period of liability of the above noted lease bond is terminated effective the date of this decision. Additionally, the bond rider to LMU bond No. 103771496 only as to including lease UTU-84285 under the coverage of this bond, is accepted effective the date of this decision.
