2. Signs and Markers

The mine identification signs were observed and found to contain the company name, address, phone number, mining permit number and mine name. The signs are in compliance with the coal rules.

4.a Hydrologic Balance: Diversions

All of the diversions are snow covered, some contain ice under the snow. As warmer conditions prevail the diversions will be checked again to make sure that they properly divert and contain the runoff conditions.

7. Coal Mine Waste, Refuse Piles, Impoundments

Waste rock piles are stable.

8. Noncoal Waste

No noncoal waste items were observed outside of the approved storage facility.

16.a Roads: Construction, Maintenance, Surfacing

Roads used by the mine site have been plowed to remove snow and provide access to the various locations within the mine permit area.
