**4.a Hydrologic Balance: Diversions**

The permittee has contracted Nielson Construction to do spring cleaning. They will redo the diversion ditches and sediment structures at Deer Creek Mine starting Monday, April 27th. I inspected diversion ditches and sediment structures during the inspection. They were opened and were functioning as designed.

**4.b Hydrologic Balance: Sediment Ponds and Impoundments**

The mine site sediment pond contained water. I did not see any hazardous conditions. The slopes and embankments appear to be stable.

All sites that I inspected were clear of non-coal waste materials.

Drainage controls along the beltline were functioning as designed.
