2. Signs and Markers

I reviewed the identification signs at the mine, the information on the sign meeting the minimum requirements of the R645 Coal Rules. It is next to the gate entering the mine site. There are also identification signs at the refuse pile and topsoil pile. The information is the same on all signs.

3. Topsoil

I inspected the topsoil piles at the refuse pile and at the main road to Soldier Creek Mine. The topsoil piles were stable with no signs of wind or water erosion.

4.a Hydrologic Balance: Diversions

I inspected the diversions and they were clear of sediment and would function as design. The permittee had clean out several diversions since the last inspection.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

I inspected the two sediment ponds. Neither sediment pond was discharging during the inspection. The mine pond did contain water, but the waste rock sediment pond was dry.

7. Coal Mine Waste, Refuse Piles, Impoundments

I inspected the refuse pile. I did not see any hazardous conditions. The diversion around the refuse pile was open and would function as designed. The permittee had done some maintenance to the diversion.

8. Noncoal Waste

The mine site was free of non-coal waste materials.

10. Slides and Other Damage

No slides or other damage was noticed during the inspection.

No new facilities since the last inspection.
