2. Signs and Markers

The mine identifications signs at the Waste Rock Facility and the Main Facility were viewed as part of the partial inspection of the Deer Creek Mine. Both of the signs contained the required information and were clearly posted at the entrance into the mining permit areas.

4.a Hydrologic Balance: Diversions

The road diversion along the access road into the Waste Rock site has been re-graded and is open and functional according to the approved design in the MRP.

5. Explosives

The powder and cap magazines are located in a remote area away from the facilities. The area is properly signed and the magazines are grounded against a lighting strike.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock pile appeared stable. No visible hazards were observed during the inspection. A lot of the recent material placed in the waste rock pile have come from a dike that was encountered underground. The material from this dike area is easily discernable as the color of the material is a gray, blue, greenish mixture and is set apart from the normal gray to black material .
