2. Signs and Markers

Signs at the waste rock site, main facility and the rilda facility were checked as part of the partial inspection. All signs were found in place at the entrance into the mining permit area. All of the signs are uniform and contained all of the required information.

4.a Hydrologic Balance: Diversions

The diversions along the main fan access road have been opened at key points to allow flow during snow melt.

4.b Hydrologic Balance: Sediment Ponds and Impoundments

The main sediment pond is not discharging. The surface is frozen.

8. Noncoal Waste

Several items of noncoal waste items were observed in the main parking lot. The major area of deposition of these items was around belt contractor vehicles. Carl Beckstead Surface Forman was contacted and a employee was immediately assigned to gather the items.
