2. Signs and Markers

Mine identification signs are in place at access points into the mining permit area. The signs contain the appropriate information to meet the criteria set forth as requirements in the Utah R645 Coal Rules.

4.a Hydrologic Balance: Diversions

The second drop inlet along side of the inclined parking lot access road from the parking lot was completely plugged. This inlet was observed on the previous month's inspection and questioned, but snow and ice were still present. Even though the inlet is not functional according to the approved design no violation or enforcement action was taken. In adherence with the Divisions new viewpoint on enforcement the inspector worked with the operator by asking that the drop inlet be cleaned.

8. Noncoal Waste

Noncoal waste items were observed in the parking lot, storage areas and along side of the access road leading to the parking lot. Items of noncoal waste were observed in these same areas the prior month. No enforcement action was taken. The inspector worked with the operator by identifying the items and asking that they be picked up and controlled in the proper approved facilities. Actions taken at other mines for similar infractions was not considered substantial enough and were vacated.
