2. Signs and Markers

The mine identification sign is in place and is visible as you enter the mining permit area. The sign contains all of the required information.

4.a Hydrologic Balance: Diversions

The crushed culvert identified in the previous inspection has been opened and is functional. The repairs to the culvert outlet near the water storage take took place immediately after being identified.

8. Noncoal Waste

Noncoal waste was observed around the main parking area and the diversion within the parking area. The operator was aware of the noncoal waste prior to the inspection (identified the prior day) and had asked that the remaining surface personnel gather the items and dispose of them in the approved containment areas. This is the fifth consecutive month noncoal waste items have been observed in these same areas. The noncoal waste is confined to the disturbed area. No offsite impact has occurred. The Division Inspector has followed the admonition given by the Division Director/Informal Conference Officer for Citation #13157 at the SUFCO Mine " The actions or conditions for which the NOV were written were such minor deficiencies in the context of the operation, that they do not constitute a violation of the MRP and did not justify an NOV being issued. The matter would have been more properly addressed by a communication from the inspector to the operator about conditions that the operator should attend to ...".

Hence no enforcement action was taken.

12. Backfilling And Grading

The portals at the main facility and the fan at the main facility have been backfilled. Either wire mesh and/or chain link fence have been placed around the portal collars and fan entrance.
