2. Signs and Markers

The mine identification signs were checked at the waste rock site, main facility, rilda facility and rilda sediment pond. All signs were ok and updated with the exception of the Rilda Sediment Pond ID sign. This sign is out of date and does not contain the current information for the operator. Upon arriving back at the Price Field Office an email was sent to Ken Fleck to inform him that the sign needs to be updated.

4.a Hydrologic Balance: Diversions

The diversions at the rilda site were checked along side of the access road way . Some sediment build up is present, but all inlets were open and functional.
