2. Signs and Markers

The waste rock site and the mine site have new identification signs posted at the entrances into the respective permit areas. The signs have been updated with a new address and contact phone number. The signs are in compliance with the requirements of the coal rules.

4.a Hydrologic Balance: Diversions

The main road diversion into the waste rock site is open and functional. Other diversions at the mine site have a light cover of snow, but remain functional.

5. Explosives

No explosives are stored or maintained at the mine site. The storage magazines are still on site.

7. Coal Mine Waste, Refuse Piles, Impoundments

The waste rock pile (refuse pile) appears stable. No visible hazards were observed.

22. Other

The mine site remains idle, awaiting demolition and reclamation activities which are planned for the spring of 2018.
