The Rilda area is drying up to the point that reclamation activities can resume.

Reclamation is taking place at Deer Creek. Reclamation began at the bottom of the Deer creek permit area, adjacent to the power plant coal storage yard. The work began on the lowest point of the C2 conveyor corridor. Earth work was taking place during the inspection. The majority of the area has been reclaimed and has also been seeded. Seeding is taking place as the reclamation on the C2 corridor advances.
