2. Signs and Markers

The identification sign for the Deer Creek mine is located down canyon from the mine site at a point that access restriction takes place. This temporary restriction during reclamation has been approved by Emery County. This identification sign displays the name, address, phone number and The mining number issued by The Division of Oil, Gas and Mining for the Deer Creek mine. The sign is in compliance with the Utah Coal Rules.

4.a Hydrologic Balance: Diversions

Reclamation diversions are being installed and operational diversions have been removed as part of reclamation.

4.b Hydrologic Balance: Sediment Ponds and Impoundments


The dike on the main sediment pond at Deer Creek has been breached. The base of the pond is going to have compaction tests done. This will ensure that placement of the final diversion channel can be placed on top of it.

22. Other

There is one section of the reclamation area that through soil tests showed SAR and EC readings. This areas general location is the parking/ storage area. A small triangular area has been identified. Addition of sulfur to this area to help remediate the problem is being considered in addition to temporary installation of a water line and sprinklers to help leach out some of the salts in an effort to drop or lower the concerns of the identified parameters.


