

NOTICE

PacifiCorp, doing business as PacifiCorp Electric Operations (PacifiCorp), and Utah Power and Light Company (UP&L), located at 324 South State Street, PO Box 26128, Salt Lake City, Utah 84126-0128, have filed a permit transfer application with the Utah Division of Oil, Gas and Mining (UDOGM), Salt Lake City, Utah. The permit transfer addresses the following UP&L/DOGM permits:

- ACT/015/017 Des Bee Dove Mine,
- ACT/015/018 Deer Creek Mine,
- ACT/015/019 Cottonwood/Wilberg Mine,

and the proposed transfer of these permits to PacifiCorp under the laws of the State of Utah and the Office of Surface Mining.

Approval of the permit transfer would allow PacifiCorp to continue operation of the mines under the existing permits. This application for transfer does not include any proposed revisions to the mining and reclamation plans.

A copy of the complete application is available for public inspection at the Emery County Recorder's Office, Emery County Courthouse, Castle Dale, Utah 84513.
