Dear Tom:

As agreed upon in the Hydrologic Section of the Permit (Des-Bee-Dove - ACT/015/018, Deer Creek - ACT/015/018, Cottonwood - ACT/015/019), PacifiCorp hereby notifies you that the annual July monitoring of East Mountain Springs will be initiated July 12, 1993.

As in the past springs within the area currently undermined and the area projected to be mined in the next five years will be reviewed and additional springs, if needed, will be added to the monitoring program. Please notify me prior to July 15, 1993 if you plan to participate in the annual review.

As we discussed on May 18, 1993, Rilda Canyon Wells P-2 and P-3 were abandoned according to stipulations listed in the State of Utah - Administrative Rules for Water Well Drillers (see attached location map). These wells were developed by West Appa and only partially penetrated the alluvial system. As part of the Rilda Canyon hydrologic investigation conducted by PacifiCorp two fully penetrating wells were drilled in November 1990 to replace the partially penetrating wells.


